BOARD VOLUNTEER SERVICE AGREEMENT

If I am chosen or elected to serve as a Volunteer Official on the Board of Directors or other committee of Community Choice Credit Union, I agree to conform to and abide by the following:

1. Attend all regular and special meetings and planning sessions when notified unless prevented in attending by circumstances beyond my control.
2. Seek to learn more about the credit union movement, Community Choice Credit Union and its services and about my individual responsibilities.
3. May attend up to two credit union Conferences/Schools each year.
4. Consider the business of the credit union and its members to be confidential in nature and not to discuss such business inappropriately.
5. Should I ever find myself under obligation to any other group or organization that is in conflict with the credit union, I shall disclose the conflict to the Board Chairman and refrain from voting or acting on issues related to the conflict.
6. Participate to the best of my ability in determination of policy and other matters. Give full attention to problems of the credit union, and vote on issues submitted or proposed for action.
7. Give all support possible to my fellow Volunteer Officials and Management of the credit union.
8. Keep personality conflicts to myself and out of credit union business.
9. Reimburse the credit union for any expenses incurred on my behalf for the attendance of conference, educational seminars, dinners and any other function that I fail to attend without giving sufficient cancellation notice or just cause.

I fully understand that failure to fulfill the duties and responsibilities of the Board of Directors or other committee under the terms of this agreement, the Michigan Credit Union Act and the National Credit Union Administration Rules and Regulations may cause dismissal as a Volunteer Official and may cause me to be personally liable. I acknowledge that failure to complete any educational requirements as set forth in the Directorship Policy may result in my removal from my position with the credit union. Should I not be able to fulfill my official obligations, I will offer my resignation. I certify also that I have a positive net worth and am current on all outstanding obligations and have met the minimum requirements to serve as set forth in the Michigan Credit Union Act. The credit union is hereby authorized to obtain a commercial or consumer report on my credit history and seek whatever information is necessary for completing a background check.

I have received written notification of the election Timeline and Election Policy and agree to abide by them. I understand that violations of these rules may result in my removal from the election ballot.
