Community Choice Credit Union's Financial Design-a-Saur contest is for K-5. Children under the age of 12 can create and submit a drawing of a financial dinosaur. The drawing should be of a dinosaur doing an activity related to finance. Please also include 1 or 2 sentences about the dinosaur and what it is doing.

This Giveaway starts at 9:00 am EST on Thursday April 1, 2021 and ends at 11:59 pm EST on Friday, April 30, 2019 ("Entry Period"). The Giveaway shall be subject to these Official Rules, and by entering, all entrants agree to abide and be bound by the terms and conditions herein and the decisions of the Sponsor.
